There is consensus that we need to do this and do it fast, but what does this mean in practice?

Leading industry speakers will give their expert insight, starting with a keynote on what the world should look like by 2030 and how the EU Green Deal lays down a vision for Europe. We investigate certifications for green products but also how not to fall into greenwashing traps.
